Introduction

ChemProtect.SK is committed to respecting the privacy of all individuals. This privacy notice explains our information practices and the choices you have about the way your personal information is collected, used, and protected when you visit our website https://chemprotect.sk/, use our services or communicate with us. The data administrator, ChemProtect.SK, collects, stores and uses your personal data within the meaning of Act No. 110/2019 Coll. on the processing of personal data, respectively within Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation). The individual purposes for which the controller processes personal data are defined below.

Information We Collect

We may collect the following information from you:

Personal Information: We collect personal information that you provide to us for the
purposes set forth in this Notice. For example, we may collect personal information
when you contact us, request that we send you materials or communicate with us.
Depending on the context of your interactions with us, the categories of personal
information we may collect from you include:

What Personal Data We May Collect

Personal contact information, this includes information that can be used to identify you directly, such as your name, email address, phone number, mailing address, and any other information you choose to provide.

Professional contact information, such as title / occupation, business / company name, business address, business email address, business phone number, business fax number, National Provider Identifier (NPI) number, and tax identification numbers.

Professional or employment-related information and credentials, such as your employment application, resume / CV, employment history, educational history, academic and professional degrees, field of study, languages, qualifications, education and training, certifications, professional association memberships, Medical / State License Number, License Status, DEA (Drug Enforcement Administration) / HIN (Health





Industry Number) Number and expiration date and references including reference letters or individuals you may direct us to for a reference.

Audio and Visual information, such as your voice and likeness as captured in video, photographs, or audio recordings if you attend our online meetings, visit our offices or leave us a voicemail.

Payment information such as a credit card number and billing and shipping addresses to complete a transaction with you.

- **Non-Personal Information:** This includes information that cannot be used to identify you directly, such as your browsing history, IP address, device type, operating system, and geographic location.
- Information Collected Through Cookies and Similar Technologies: We may use cookies
 and similar technologies to collect information about your activity on the Website.
 Cookies are small files that are placed on your device by a website when you visit it. They
 store information that can be retrieved by the website on your subsequent visits. You
 can manage your cookie settings through your web browser.

How to Manage Cookies

You have the right to choose to accept cookies. However, they are an important part of how our Sites work, so you should be aware that if you choose to refuse or remove cookies, this could affect the availability and functionality of the website. If you do not wish to receive cookies, you may set your browser to reject cookies or to alert you when a cookie is placed on your device. You may also delete cookies as soon as you leave the website. - To comply with legal and regulatory requirements.

Disclosure of Your Information

We may disclose your information to the following third parties:

- Service providers who help us operate the Website and Services;
- Law enforcement or other government agencies, if required by law;
- In connection with a merger, acquisition, or other business transaction.

We will not sell or rent your personal information to third parties.

Data Retention

We will retain your information for as long as necessary to provide the Services, comply with our legal obligations, resolve disputes, and enforce our agreements.

Your Choices

You have the following choices regarding your information:

- You can request that we delete your personal information.
